<p>2, Finances</p> <p>a. The current balance of our funds held at ART is £7076. We have paid for all the expenses associated with the new walks booklets, we have put £1000 aside as a contribution to the Festival, there are a few small expenses to come, but don't have any other major liabilities. Therefore, there is about £6000 available.</p> <p>b. The current balance of our account at Lloyds is £2948.12</p>

Lots of very complimentary comments have been made. • 5000 copies of the booklet printed, about 3500 have been distributed so far. Habitats</p> <ul style="list-style-type: none"> • The official opening of the revamped Chellow Dene wetlands took place on Wed 18th Sept. • Design of a revamp of Pitty Beck wetlands is underway by ART. There has been a lot of arson in the area recently, and Mike attended a meeting with the Fire Brigade and others to discuss a plan – the info has been passed on to ART. • The possibility of a wetland and fish pass at the Sams Mill weir has become a possibility. The landowner, who wants planning permission for an industrial development, has agreed that the site can be used and will make a financial contribution. The project now goes over to ART to see if 	

<p>they can achieve it.</p> <ul style="list-style-type: none"> Fagley Beck will be one of the focus points of the ART Roots in the River. This is a Lottery funded project over the next few years, using the Barratt Homes money handed over as an Enforcement Undertaking.
